

To be displayed beside all copying machines throughout all licensed Further Education and Sixth Form Colleges

This institution has a CLA Licence enabling staff and students to copy extracts, within clearly defined limits, from books, journals, magazines and other periodicals published in the UK, Argentina, Australia, Austria, Belgium, Canada (including Quebec), Denmark, Finland, France, Germany, Greece, Hong Kong, Iceland, Ireland, Italy, Jamaica, Luxembourg, Mexico, Norway, Netherlands, New Zealand, Singapore, South Africa, Spain, Sweden, Switzerland, Trinidad and Tobago and the USA *

What the Licence covers

Paper Copies

The Licence permits the photocopying (including copying onto acetate) of extracts from all Licensed Material published in the UK (and the above listed countries) except those works shown on the List of Excluded Categories and Excluded Works.

Digital Copies

The Licence also permits scanning and retyping of extracts from books, journals and magazines published **in the UK only**. Use of licensed Digital Copies in presentation software (e.g. PowerPoint™) is also covered. Copies can be stored for the duration of the licence and may also be faxed under this provision.

You can make and distribute as many copies as you require for each particular purpose subject to the following extent limits:

- **one complete chapter** from a book,
- **one article** from a journal or magazine,
- **a short story or poem not exceeding 10 pages in length** from an anthology,
- **in the case of a published report of judicial proceedings, the entire report of a single case,**
- **or 5% of the publication, if greater than the above**

The licence permits copying of artistic works contained within Licensed Material covered by the Licence. Subject to the availability of commercial editions, the creation of enlarged copies and copies onto acetate are also permitted. The same limitations (above) apply to these copying types. Copies may also be made for meetings of staff, managers or parents.

What the Licence does not cover

- **Printed Music** (including the words),
- **Newspapers,**
- **Maps, charts, or books of tables,**
- **Some Correspondence Courses** (see the CLA 'Explanatory Leaflet'),
- **Publications which specifically say they are not to be copied under the CLA Licence,**
- **Published examination papers and published tests,**
- **Workbooks, workcards or assignment sheets,**
- **Privately prepared teaching material,**
- **'Copy Permitted' publications** ('photocopiables') (these are sold with a licence from the publisher permitting photocopying to the extent indicated on the publication).
- **All items on the *List of Excluded Categories and Works*.**

The List of Excluded Categories and Excluded Works should be on display next to all copiers in the college and is available on the CLA website. Permission to copy excluded items or quantities in excess of the above stated limits (including the making of any digital copies of material published outside the UK) must be sought from the rightholder (publisher, author or artist) on each occasion.

Limitations on the use of digital copies

Digital Copies may not be edited or manipulated or modified in any way except for changes necessary to enable users with a disability (such as visual impairment) to access the work. Staff are, however, allowed to mark copies to add emphasis. Retyped extracts must be reproduced verbatim, including all punctuation. The use of optical character recognition (OCR) software is not permitted under the Licence. All Digital Copies must be identified with the details of **author / artist, title, publisher and ISBN / ISSN** at the foot of each page so that the source of any extracts taken from Licensed Material can be identified.
