

# Copying Guidelines

## For NHS in Wales

The CLA Licence for the NHS in Wales permits authorised persons to make Paper or Digital Copies of content from most books, magazines, journals and periodicals as well as from selected digital publications subject to certain terms and conditions.

Copies may be made from publications including those to which you subscribe and from articles or press cuttings provided by licensed external suppliers where a copyright fee has been paid (e.g. from a PR or press cuttings agency or the British Library).

### The licence permits:

- Photocopying
- Scanning
- Copying of unaltered digital content, e.g. a PDF file from electronic subscriptions or scanned articles circulated by email.

### Types of publication covered

- Books
- Magazines
- Trade press
- Journals
- Copyright fee paid copies
- Periodicals
- Law reports
- Reference editions
- Press cuttings received from a press cuttings agency
- Some digital versions of the above (see Digital publications below) and other digital originals

### What can I use copies for?

Internal communications, for example:

- To share with colleagues at meetings or briefings
- For internal training sessions, journal clubs etc
- Health & Safety or Environmental awareness
- For research & development
- For PR or Media relations
- Information relating to an illness, condition or treatment for a patient

### How much can be copied?

On each occasion you may copy up to 5% of a publication, a single chapter of a book or up to two articles from a periodical, whichever is the greater. Where the issue or a substantial part of it is dedicated to a particular theme, any number of articles dealing with that particular theme may be copied.

### Who can make and receive copies?

Any authorised person, individual consultants or agency workers, employees and workers of any HEI or other Library Service Provider who are on temporary or permanent placement with, or providing library services to the NHS in Wales but only while they are engaged in the business of the Licensee or in providing consultancy services to it and students of any HEI who are on temporary or permanent placement with the Licensee for training and/or receiving instruction as part of their course of study at their HEI but only for the purposes of such training and or instruction. The term 'consultants' shall also include those members of a Designated Committee (not otherwise being an Authorised Person) when acting in connection with the activities of the Designated Committee. For the avoidance of doubt – copies may only be made and distributed within the NHS in Wales and not with NHS in England, Northern Ireland, Scotland or the Isle of Man.

### Storage of Digital Copies

You may store Digital Copies (e.g. scanned images or PDF's received by email) on your PC or personal server space. Additionally individual licensed copies may be held on your organisations intranet for access by authorised users for a period of up to 30 days.

**International publications**

**Excluded works**
