

# Copying Guidelines

## For Employees

The CLA Digital Pharmaceutical Licence permits UK employees to make Paper or Digital Copies of content from most printed books, magazines, journals and periodicals as well as from selected digital publications subject to certain terms and conditions.

Copies may be made from publications including those to which you subscribe and from articles or press cuttings provided by licensed external suppliers where a copyright fee has been paid (e.g. from a PR or press cuttings agency or the British Library).

### The licence permits:

- Photocopying
- Scanning
- Copying of unaltered digital content, e.g. a PDF file from electronic subscriptions or scanned articles circulated by email.

### Types of publication covered

- Books
- Magazines
- Trade press
- Journals
- Periodicals
- Law reports
- Reference editions
- Press cuttings received from a press cuttings agency
- Copyright fee paid copies
- Some digital versions of the above (see Digital Publications below) and other digital originals

### What can I use copies for?

#### Internal communications, for example:

- To share with colleagues at meetings or briefings
- For market intelligence
- For research & development
- For PR or Media relations

#### External distribution

- Paper or digital copies may also be sent to
- Healthcare professionals and others making unsolicited requests for therapeutic or technical information about a product.
- Regulatory authorities in any jurisdiction. You may also send them to external regulatory advisers in connection with an application or regulatory advice.
- External advisers in connection with the preparation or prosecution of legal proceedings.
- Patent authorities in support of a patent application in any jurisdiction.
- **Important:** A **copyright notice** should be attached in all of the above scenarios. For clarity, copies may not be provided for any external marketing purpose.

### **How much can be copied?**

On each occasion you may copy up to 5% of a publication, a single chapter of a book or two articles from a periodical, whichever is the greater.

### **Who can make and receive copies?**

Any UK employee in your organization including individual consultants or agency workers.

UK employees, contractors and agency workers may send paper or digital copies to overseas employees (including affiliates and subsidiaries). When sending an electronic copy (e.g. a PDF) to an overseas recipient, the recipient may only print a single copy unless they have a further local licence to allow further uses.

### **Storage of Digital Copies**

You may store digital copies in an indexed and searchable literature database (such as a local product literature database) providing it is accessible only to employees and contractors. You may also store digital copies in a personal or work-group folder or in a dim archive where you might, for example, store copies for the purpose of regulatory submissions, medical information and patent applications. Additionally individual licensed copies may be held on your company intranet for access by authorised users for a period of up to 30 days

### **International publications**

CLA has agreements with similar agencies in most major overseas territories enabling International publications and content to be copied under the CLA licence.

### **Excluded works**

Please note that there are some titles and publications that are excluded from the licence and you will need to contact the copyright owner directly for permission to copy them.
